



THE -CHARTER THE NATIONAL ASSOCIATION OF DEHKAN (FARMERS) OF REPUBLIC OF TAJIKISTAN



I. The general Provisions

- 1.1 The NADF Dehkan (farmer) facilities and Republic of Tajikistan, hereinafter referred to as "NADF" is created by association Dehkan (farmer) facilities and with the purpose of assistance and promoting economic activities and protection the rights Dehkans (farmers) on the basis of the Law of Republic of Tajikistan «About Dehkan (farmer) facilities" and other current legislations of Republic of Tajikistan.
- 1.2 The NADF is the independent subject of managing and operates on the basis principles of proportionality of managing. Has the property, independent balance, the bank account, including the currency account, a seal, a stamp, the firm form etc.
- 1.3 The NADF is organized from the moment of the state registration and in the activity is guided by the legislation and the present charter.
- 1.4 Dehkan (farmer) facilities being have recognized as members of the NADF, including their Association and have approved the present Charter

II. Legal status of NADF

- 2.1 Dehkan (farmer) facilities which enter and the NADF have rights on a site of the ground and property, including has the right to be the claimant in court.
- 2.2 NADF is considered the legal person from the moment of its registration, signs contracts, has property rights, including rights on participation civil process
 - carries out the activity it is not dependent and has necessary means for him(it)
 - has the right to use bank credits for the basis the conclusion of the contract
 - has the right to use monetary investments of legal and physical persons of the foreign states
 - has the right to get movable and immovable property, actions of other kinds of securities not forbidden to the law
 - has the right it is open monetary and currency accounts in banks. To lead(carry out) cash operations and settlement - debt operations with use of monetary and currency means
 - has the right to be property monetary stock exchange broker and dealer -broker activity
 - has the right it is open representation, branches as well as in Republics of Tajikistan, and abroad.
 - has the right to be a member of the international organizations
 - has the right to participate in development information and analytical, normal and legal certificates of Republic of Tajikistan be relative Dehkan (farmer) facilities(economy) and agro industrial sector as a whole
- 2.3 Has the right to rent, a premise with the purpose of the effective activity

- The NADF is not responsible under the obligation of founders and founders responsible within the limits of payment of membership dues.
- Has the right, to access farmer bank, with the purpose development Dehkan (farmer) facilities is open.



111. Primary activities & goals of NADF

The main prospective goals of NADF are: Improvement and advocating the rights of Agricultural producers; Farmers, Associations of Farmers, water users, agricultural producers, cattle breeding sector and etc. Strengthening & supporting capacity building of Farmers, Association of the Farmers, agriculture producers.

- 3.1. Protection social, economic moral personal and encouragement Dehkan (farmer) facilities.
 - Participation in reform of agro industrial sector.
- 3.2. Active participation in distribution and the report up to facilities of industrial means which are signed by the contract between the government of Republic of Tajikistan, investors the Ministries and associations.
- 3.3 the NADF for the founders will undertake all efforts for maintenance with basic means of production with use of crediting due to structural divisions of the enterprises etc.
- 3.4 Prepares financial papers, has the right will carry out meetings to conclude contracts with foreign and local investors
- 3.5 Provides protection of rights and legitimate interests of the founders by creation of complex legally advisory divisions
- 3.6 To organize publishing activity to issue magazines, to lead researches and other publishing.
- 3.7 Service, development and realization of new methods of managing in conditions of market economy.
- 3.8 Information support, training, consultation of farmers and to bases agribusiness, including micro financial activity, crediting, micro financing, leasing and others.
- 3.9 Development examination and realization of projects and programs of micro financing, crediting, charitable actions, innovational and investment.
- 3.10 Development of programs educational progressive instructions for farmers and, realization of training rates, creation of the scientific - indicative centers.
- 3.11 Qualification and a training for a new profession of the staff, realization of seminars, congresses, symposiums, round tables as in Republics of Tajikistan, and abroad.
- 3.12 With the purpose of protection of rights of laws and founders the NADF has the right to create departments, groups, representation etc.
- 3.13 For achievement of the purposes and problems, the NADF has the right to use all having means and opportunities, not inconsistent to the current legislation of Republic of Tajikistan.



IV. Membership to NADF

- 4.1 Members of the NADF may be Dehkan (farmer) facilities of , agricultural the enterprise cattle-breeding the enterprise, cocoon farming, fish farming, poultry-farming, gardens, individual economic persons including the organizations and the enterprises engaged in industrial serving, intermediary and other activity in sphere of an agriculture.
- 4.2. Membership in the NADF is carried out by means of promotion by his presidium with the account the statement of a nominee, in general meeting.
- 4.3. Membership and the termination membership in the NADF is carried out on a voluntary basis, also the NADF has the right to deduct any member of the NADF.
Deduction from the NADF to occur in a case infringement by a member of authorized norms. The decision about deduction is accepted by Presidium and affirms general meeting.

V. The Rights of members' NADF



- 5.1. Rights in activity of the NADF.
- 5.2. Rights to be to elect or select other members in the NADF.
- 5.3. To receive the necessary information on a course of activity of the NADF.
- 5.4. To use all incentive means of the NADF.

VI. Duties of members' of NADF

- 6.1. Observance of the present Charter
- 6.2. To execute the decision General assembly and presidium
- 6.3. To pay in time membership fees
- 6.4. To represent in time reports structural division of the NADF
- 6.5. To allocate the certain part pure, the profit Dehkan (farmer) facilities to the NADF

VII. Management of NADF



- 7.1. The supreme body of the NADF is general meeting which will held once a year, including the NADF has the right to convoke General meeting necessarily.
- 7.2. Into the exclusive competence of the NADF enter:
 - Change and addition in the charter of the NADF
 - Creation of an agency and the preliminary termination of his activity.
 - Election of a revision committee.
- 7.3. The representation in General meeting the NADF to occur by means of one representative from one member, the Assembly is considered competent of that case if in it participates not less 3/2 participants
- 7.4. The structure of presidium consists of 11 persons elect from among veterans of work etc.
- 7.5. General meeting selects members of presidium to terms on five years by open or closed voting. One person has not the right to be selected in a responsible post of the NADF more than two times in succession.
- 7.6. The presidium to supervise over activity of the NADF during intermediate General meetings.
- 7.7. The presidium of the NADF has the right executive and representative body Dehkan (farmer) facilities of bodies.
- 7.8 The presidium is executive and administrative body and supervises activity of the NADF in decisions, which do not depend on general meeting.
- 7.9 The competence of the chairman of Presidium:
 - Has the personal responsibility for the lawful and proved activity of the NADF, supervises over general meeting and assembly of the NADF.
 - Defines(determines) rights and duties of the assistant and workers of structure of presidium
 - Solves all complaints and existing problems
 - Opens accounts in banks
 - Accepts and dismisses workers of the NADF
 - Represents the NADF in all state and not state organizations.
 - Has the right to create departments, groups, laboratories with the purpose, effective work of the NADF

VIII. Rights and duties of the Chairman



- 8.1. The chairman is selected General meeting for the period of five years.

- 8.2. The chairman to supervise over presidium of the NADF, organizational and industrial affairs of the NADF.
- 8.3. Represents offers be relative improvement the legislation in the field of agriculture to parliament of the country.
- 8.4. Organizes information - analytical communication of the NADF.
- 8.5. Considers joint projects and agreements of the NADF and the government and represents their general meeting then signs.
- 8.6. Carries out a financial politics of the NADF.
- 8.7. To supervise over activity of heads regional zone, regional, and rural associations Dehkan (farmer) facilities and establishes the control of their work.
- 8.8. Concludes contracts on behalf of the NADF.
- 8.9. Operates property and the financial assets allocated with general Meeting to the NADF.
- 8.10. Prepares projects of export and import activity of the NADF for consideration.
- 8.11. Protects interests of the members before commercial structures of the action which are available for the NADF.
- 8.12. Defines functions and problems of the assistants.
- 8.13. Prepares position of the device of the NADF, it I shall sweep away the maintenance and submits them on consideration and the statement to general Meeting.
- 8.14. To supervise to devices of the NADF over the general director. The manager of a department under the finance, managing a staff department accounts department etc.

IX. Property of NADF



- 9.1. All property a building, a construction, engineering, tools and stock, a liability and another which the NADF is on independent balance and means available on the current accounts are considered as the property of the NADF.
- 9.2. The property of the NADF may be formed for the account property of legal and physical persons.
- 9.3. The Property of the NADF also may, is increased greatly due to sponsor's and charitable the help of legal and physical persons. And due to profits that, received from economic activities.
- 9.4. The Received net profit of the NADF goes on a payment and encouragement of employees, rent of office and other expenses of the NADF.
- 9.5. The entrance Fee for membership in the NADF makes 8 somoni 60 diram.
- 9.6. The entrance Fee may be born in monetary or property forms.
- 9.7. Cost and the order of payment introductory and membership dues are established by general Meeting of members of the NADF.



X. Auditing Commission

- 10.1. The revision committee is selected General meeting in quantity of 9 persons.
- 10.2. Auditing structure on receipt to general Meeting of the NADF.
- 10.3. A revision committee from the members selects the chairman and the secretary.
- 10.4. Audit is made no more a once per one year.



XI. Reorganization and liquidation of NADF

- 11.1. The decision on General assembly of the NADF
